

ConnectCentral 2017 Contest Official Rules

1. **No Purchase Necessary; Entry Instructions.** NO PURCHASE OR PAYMENT OF ANY MONEY IS NECESSARY TO ENTER. A PURCHASE WILL NOT IMPROVE THE CHANCES OF WINNING.

ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED AND ON THE SKILL OF THE ENTRANT. VOID WHERE PROHIBITED BY LAW OR WHERE REGISTRATION OR BONDING REQUIRED. SUBJECT TO ALL FEDERAL, STATE AND LOCAL LAWS.

To participate in the ConnectCentral 2017 Contest (the "Promotion") beginning at August 9, 2017 at 11:59 PM Eastern Time ("ET") and ending on August 31, 2017 at 11:59 PM ET, complete the statement, "I want to go to ConnectCentral2017 because _____" and post the statement on Facebook, Twitter, or LinkedIn. Your posting must include #ConnectCentral2017 and #RingCentralPromo as a "hashtag" as part of your posting (collectively, the Entry"). Sponsor's computer is the official time-keeping device for the Promotion. Time and eligibility of Entry will be determined by Sponsor in its sole discretion. On or about September 1, 2017, Sponsor will select the winner.
